Eligible dogs will be identified by an asterisk in the steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers, household members and current assistants to professional handlers may not exhibit the dog in any AKC National Owner-Handled Series competition during the entire show. A current assistant is defined by anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any show during the cluster/weekend, however current assistants that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may participate in NOHS.

- · Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in the Four-to-Six Month Beginner Puppy Competition.




